DLS PEER ANALYSIS


- The Department of Local Services (DLS) has provided Maynard with a list of Peer Communities
- In addition to using factors below to find comparable communities, DLS narrows search to only towns with their own school district, and to towns within 60 miles of Maynard
- The DLS municipal databank provides budget data we can benchmark against

Factors Used (in order of weight):

- Population
- Total budget
- Per capita equalized property value (EQV)
- Per capita income
- Percentage of total property valuation that is commercial/industrial/personal (CIP)
- Population density
- Revenue sources for the budget


MUNICIPAL GENERAL FUND EXPENDITURES

- Assabet vocational falls within Education


EXPENDITURES MINUS EDUCATION

- Debt service will go up significantly in FY25 due to Green Meadow

GF "TOWN SIDE" EXPENDITURES




- GF Expenditures excluding education, benefits, debt service

 Public Safety, and Public Works
- Maynard is in line with peers, spends less than neighbors or state average

EDUCATION EXPENDITURES






- Administration, Teachers, Other Teaching Services and Insurance are categories where Maynard spends more per pupil

- Maynard is now 20% higher than state average per pupil

In District Expenditures





AVERAGE SINGLE FAMILY TAX BILLS

 - Potential stormwater utility
